## **Development and Designated Meets**

General discussion regarding Designated and Development meets in a post covid environment. The loss of the Hawera Swimming Club Meet was noted as was the recent travel of swimmers to Manawatu and Waikato Meets to obtain qualifying times.

## Officials Training

The 2023-2024 Calendar review - The Committee discussed the importance of Meet's as an 'officials' training ground. A reduction in overall Meets lifts the importance of 'Club Night's for official training and testing and sign off. This is to be re-laid to the Clubs.

The Committee discussed opportunities for senior swimmers to participate in the running of Meets as a contribution towards ST.

There are a number of trainees at both Aquabladz and Stratford that will potentially be eligible to enable sign- off prior to this Meet or as part of the first Session.

#### **New Pool**

Rowan and Daniel reported on the new Pool and its readiness for Competition swimming. There remain some items that may not be fixed for upcoming Meets including lighting. These are matters for which the Council cannot control and the officials are able to work within these parameters and take a 'best of ability 'approach.

There are defective items that the Council has responsibility for and is able to correct/fix including the tightening of the lane ropes. Daniel to request lane ropes are fixed prior to next Competition Meet.
