Jane Gadsby, a contact through Cath Tippett might be able to provide this service for us. If we were to get a full audit it would be in the region of \$5-6k but a review can be \$2,500 or less. We would <u>not</u> need an accredited auditor as this requirement is not included in our constitution.

Accountants are hesitant to do reviews, so we were fortunate to have CMK in the past. If this can't be done before the AGM, we will get it certified at a later date.

## NZSC

Carol noted that there were some concerns around teams not wearing Taranaki uniforms. Kim said that this only happened once on the Tuesday morning of the event in the morning because the clubs weren't sure of protocol. From Wednesday onwards the swimmers wore ST gear in the morning and club gear in the afternoon.

It was clear that the expectations need to be clarified and suggested that something be put in writing and sent out to every club before a national event.

Kim pointed out that whilst you are a member of Swimming Taranaki, as a swimmer you also belong to a club.

It was decided that in the morning Swimming Taranaki clothing (caps and clothing) should be worn and in the afternoon/finals club gear should be worn.

Daniel confirmed that before each swimmer's appearance at their first national meet, they are given a hoodie, t-shirt and cap. The team managers need to keep us updated as to who requires this gear.

Kim said that Craig Elliot, the Stratford coach had brought up the issue of basketball shorts being worn in the evenings which is not acceptable, and it should be black shorts although Daniel pointed out that this is a club issue.

Carol suggested that in the reminder regarding protocol for wearing ST and club gear we need to also remind clubs that dress needs to be smart and please could any shorts/pants be black.

## **GENERAL BUSINESS**

## Junior Festival/Taranaki Summers dates

Carol said that the date for the Junior Festival one week after Taranaki Summers is to close. It was suggested that the Taranaki Summers be moved to a week earlier, swapping with one of the Summer Series dates. This needs to be revisited next meeting.

## <u>DIV 2</u>

Aquabladz' accommodation was fully paid by ST which fully met the requirements of Aotearoa who gave us \$5000. We didn't receive funding for Stratford (as there were no gaming machines in this area) but did for Hawera, however, their receipts for accommodation were not accepted and so consequently we had to return some funding. \$5000 less the money returned (\$739.16) divided between 11 swimmers around the region is \$387.35 per swimmer.

The board agreed to give retrospective financial support for this event to the Hawera and Stratford clubs. This will be \$774.70 (2 swimmers) to Hawera and \$1239.52 (3 swimmers for 5 nights plus one swimmer for one night) to Stratford.

## New blocks at Todd Energy Aquatic Centre

New blocks have been installed in the outdoor pool at Todd Energy Aquatic Centre which opens up the long course pool for swim meets. It would be good to have a long course pool to race in but this will depend on the cost that the Aquatic Centre charges for pool hire which has previously been expensive on a daily rate.

Louisa to get a price for pool hireage for one day (Saturday or Sunday) for a LC meet. The dates would need to be between October and March due to this being an outside pool but this could attract 'out of town' swimmers looking to get LC times.

# ST Caps

Carol commented that Aquabladz were complaining that the new ST caps were not fitting well and slipping off the swimmers' heads. Louisa contacted Craig at Stratford Flyers to see if his swimmers had experienced similar issues, but he said that his 'swimmers had been wearing them without any real issues'. He did mention that the caps need to be worn a few times before they are 'grippy' and often slide off conditioned hair which is normal for any cap. Carol to get more details of the problems experienced at Aquabladz and to discuss with Louisa.

## **Methanex Blocks**

Paul R said that he had been in contact with Jason, the pool manager at Methanex Bell Block. Jason said he had been really pleased with how the Taranaki Winters went but had been trying to get funding from the board for new blocks for years.

Could ST write a recommendation that new blocks would enhance the performance for al-l competitive swimmers to Bell Block Pool Board? The cost is in the region of 22k for 6 blocks. Louisa to speak to Jason and draft a letter for the Bell Block Pool Board.
